House Transportation - 3:30 PM – Work Session on green transportation. *MONITOR*.

Senate Ways & Means - 4 PM – Hearing on **SB 5693** - Making 2021-2023 fiscal biennium supplemental operating appropriations. *MONITOR*.

House Community & Economic Development – 10 AM – Hearing on **HB 1620** - Addressing the response to extreme weather events. Sign in **SUPPORT** – establishes a grant program to assist local communities in responding to extreme-weather events.

House Labor & Workplace Standards – 10 AM – Hearings on **HB 1745** - Providing discretion to the director of the department of labor and industries to waive or modify penalties and violations when action is taken to avoid imminent danger of loss of life or serious injury; and **HB 1794** -- Requiring an

House Local Government - 10 AM – Hearings on **HB 1660, HB 1711,** and **HB 1337** - Concerning accessory dwelling units. *MONITOR*.

Senate Housing & Local Government – 10:30 a.m. – Hearings on **SB 5513** - Expanding flexibility of existing lodging taxes for affordable workforce housing; and **SB 5593** - Concerning urban growth area boundaries. *MONITOR*.

Thursday, January 13, 2022

Senate Housing & Local Government -- 8 AM — Work Session: Overview of reports on the state's housing affordability crisis and the racial wealth gap in housing. Hearings on SB 5556 - Providing financial relief to hotels, motels, and other lodging facilities impacted by the eviction moratorium; and SB 5662 - Concerning intergovernmental coordination to address transitioning persons encamped on state public rights-of-way to permanent housing solutions. Recommend we MONITOR 5556, which stipulates that, "A lodging facility housing long-term guests under the eviction moratorium is exempt from taxation for property taxes levied for collection in 2022 and 2023, as described under this section"; 5662 is one I recommend we sign in SUPPORT of. It calls for inter-governmental coordination and, among other things indicates Department of Commerce "shall collaborate with the office of intergovernmental coordination on public right-of-way homeless encampments created in section 2 of this act on developing and implementing a statewide effort to reduce the number of persons encamped on the state public rights-of-way by transitioning to permanent housing solutions. The department shall use any funds appropriated by the legislature for this purpose to provide grants to local governments or nonprofit organizations to meet the individual p. needs of persons encamped on state public rights-of-way in order to facilitate their transition to permanent housing."

Senate Labor, Commerce & Tribal Affairs - **8 AM** – Hearing on **SB 5649** - Modifying the Washington state paid family and medical leave act. *MONITOR*.

House Finance - 8 AM – Hearing on **HB 1643** - Exempting a sale or transfer of real property for affordable housing to a nonprofit entity, housing authority, public corporation, county, or municipal corporation from the real estate excise tax. *Sign in SUPPORT*.

Senate Agriculture, Water, Natural Resources & Parks - 1:30 PM — Hearings on **SB 5504** - Extending current discover pass free days from state parks to all state recreation sites and lands; **SB 5608** - Concerning free public access to state parks and lands; and <u>SB 5746</u> - Concerning drought preparedness, response, and funding. *MONITOR*.
