House Rural Development, Agriculture, and Natural Resources, 8 a.m. – Hearing on **HB 2559,** concerning payments in lieu of real property taxes by the Department of Fish & Wildlife. *WWRC requesting that WRPA sign in SUPPORT – plan to do unless concerns?*

House Housing, Community Development, & Veterans, 9 a.m. – Work Session: Overview of the Housing Trust Fund.

Senate Housing Stability & Affordability, 1:30 p.m. – Work Session on GMA impact fees. Hearing on **SB 6386** reducing impact fees for low-income housing – allows local governments to waive the fees without revenue-offset requirement; **SB 6411,** Governor-request bill on the Multi-Family Tax Exemption program (MFTE); **SB 6446,** authorizing cities and counties to impose a 5 percent excise tax where the vacant home rate is over 30 percent. *MONITOR*.

Senate Transportation, 3:30 p.m. - Work Session: Road Use Charge Assessment Final Report.

House Transportation, 3:30 p.m. – Hearing on **HB 2385**, which would elevate maintenance and preservation to be the pre-eminent transportation planning goal for the state; **HB 2358** modifying stop-sign requirements for bicyclists; **HB 2461**, including health in transportation system policy goals; and **HB 2688**, adding elements such as accessibility, climate, health, and equity and environmental justice to transportation policy goals. *MONITOR*.
